

APRN Alliance

Wendy Monrad, CDR, USPHS, CRNA, MSN APRN Alliance Liaison November 2017



This year has been very eventful for the APRN Alliance. This group, which is just now becoming official with licensure and non-profit status, lead the charge to see our state nursing regulations updated in order to implement SB53 (APRN Consensus Model) signed into law last July. The Alliance took on the challenge of crafting the language changes and then submitted it to the BON for approval and submission to the public for an open comment period back in August. The BON met last week to confirm the changes after an arduous and frankly ridiculous comment period. They approved all of the changes with the exception of section 430 (Scope of Practice). The section was repealed due to vague wording. The intent of the change was for the BON to defer individual APRN Scopes of Practice to the respective professional organizations. This is simple for CRNAs and Certified Nurse Midwives (CNM) as we have one single organization. Nurse Practitioners and Clinical Nurse Specialists have multiple or hard to identify organizations. The BON repealed this section and replaced with the original. They will likely address this in the near future. A big thank you to all the CRNAs, physicians and professional organizations that rallied around our cause to address the misinformation presented in the public comments from our usual misinformed adversaries. We really came through! CRNAs are now APRNs and LIPs - officially - in the state of AK!

As the Alliance gets established, they will be calling for the four individual APRN state associations to join as associate members. The dues have not yet been determined. The mission of the Alliance is to be the eyes and ears for APRNs on legislative and regulatory issues. They plan to contract with a lobbyist that would be available to all four organizations. This group has also lobbied strongly over the last few months for the four APRN groups to remove membership from the Alaska Association of Nurses (AaNA). Two of the groups are quite small and not able to afford dues in both. Not surprisingly, this has created some concern from AaNA. This is now being addressed by the Alliance. Your AKANA board is also considering this move. We have not as yet removed membership from AaNA as AANA requires us to have an active lobbyist as part of the requirements for OHA funding. This is also important for us as we often need their services, as evidenced by the recent battle for regulation changes. More on this in the near future.
